BOARD ROOM NEWS... From September

- Kevin reported that as soon a CD matures (in late Oct) the \$5000 check to MIASF for services will be disbursed and the balance of the funds will be invested as agreed.
- Brokerage Shows: Art reported Dane Graziano of Show Management was meeting with Miami officials regarding the Miami Brokerage Show so he was unable to attend the board meeting as previously planned. Show Management reports the Brokerage Show looks good for this year but needs figures as to the economic impact the Boat Show has on Miami.
- MIASF FT LAUDERDALE BOAT SHOW: Peter Grimm reported that last year there were 126 boats over 80' this year there are 150-160 over 80'. They expect revenue up by 5%. He also reported that a cap was placed on the yacht's display space rate. Boat show will be Oct. 30- thru Nov. 3rd.
- Road Show Boat Show: MIASF produces a traveling show selling Ft. Lauderdale. MIASF has suggested that FYBA may want to review the program and see if they want to participate.
- Charter Yacht Show: Art reported he has discussed the show with Show Management to see how it can become a source of revenue for FYBA. The possibility of opening the show to the public and moving the venue to Ft Lauderdale was discussed. This year it will remain in Paradise Island, Nov. 30 - Dec 2nd.
- BUC: Warren reported that 20 test sites are complete. Warren will try to set up the BUC demo for the next meeting.
- Legislation: Art Holler reported that Clay Shaw has agreed to sponsor legislation to allow foreign flag yachts 80' or larger to be exempt from paying duty so they can come into this country and be exhibited for sale while at the boat show. Hopefully it will pass the legislature in time to be announced at the boat show. The 80' length was determined from the international definition of a mega yacht.
- Seminars: The Dale Carnegie Seminar for the West Coast has been scheduled for Oct. 17 at the St. Petersburg's Yacht Club. Barbara reported the sales portion of the seminar has been modified. CIT will sponsor a portion of the seminar.
- Marine Council/FYBA Seminar: Everyone needs to make a few phone calls and get people registered.
- SOCIAL: 12 Affiliate members have signed up for display space at the Sept. 3rd thursday Brokerage show
- YABA: Newport show looks strong.
- MYBA: Kevin reports MYBA is revising their contracts and that FYBA should review them
- Other Business: MIASF and economist, Tom Murray, have asked for volunteers, who specialize in mega yachts, to help on a survey and study. Volunteers were secured.
- Rae reported Palm Beach Brokerage had 18 boats on display. Palm Beach Brokers sent their thanks for sponsoring the show and would like it to continue in 1998.
- Rae reported approximately 300 complimentary newsletters were mailed to licensed sales people.


